ADVOCACY REPORT January 2024

The Advocacy Committee met to plan and budget for 2024.

- The Gym project from 2023 would be put on hold in 2024 due to Lawrence's other commitments. Instead the budget from the Gym project would be used to market May DV awareness month using a paid social media campaign.
- A new Advocacy event was proposed to reach women in the community. The main aim being to help women build awareness and knowledge of community services which support women and their wellbeing in the Moreton Bay Region. Proposed time of the event is just before the 16 Days of Activism. Details will be provided as the Advocacy team develop the project. Grants will be sought to fund the cost of hiring a hall for a day as suggested by Carol who spoke to Terry Young re the event after the meeting.
- A billboard will be sought to advertise DV awareness electronically or fixed. The billboard will be selected for a high traffic area in the local district. Targeting women and DV awareness.
- In the next couple of months managing centres of local shopping centres and toilet blocks will be contacted to display toilet signs raising awareness of DV and emergency contacts. Signs will be covered in Perspex before being installed.

CONSTITUTION & BYLAWS REPORT January 2024

The Draft Constitution with necessary changes from Zonta International was approved by the Zonta Club of Caboolture at the September Dinner Meeting 2023.

In this Draft, reference was made to the Internal Grievance Policy and Procedures in the Constitution, and the Constitution Committee started to develop this policy for our Club towards the end of 2023 and the beginning of 2024. At this stage, it was intended that the full set of procedures would not be included in the actual Constitution, instead just reference to it. This would overcome the problem of having to change the constitution if there are any future changes in the procedures.

Final editing of the Constitution (checking page numbers in index, noting of financial year details for our Club, the red-typed changes in draft to become normal black-typed version) needed to be made before submitting to OFT for registration. This follow-up work was not completed until January.

At the January Board Meeting, Cecil spoke to the Board members about an early draft of the set of grievance procedures, based on the model of the Office of Fair Trading. She obtained suggestions about the terminology used by OFT, and the name of the policy. Further suggestions were made to make the procedures simpler. However, because of a possibility of a name change to the Policy and Procedures, the President has suggested that the club-approved constitution (but not registered) be held back until the matter of grievance procedures is settled.

The Constitution Committee will be considering these changes and a draft will be submitted to everyone for comment and to suggest any further changes. A committee meeting on 7 February has now been arranged for this purpose.

NOTE:

This matter is now urgent as after further contact with Office of Fair Trading by Cecil just last week, OFT has now emphasized that the procedures in full must be contained in the Constitution, not just make reference to it. (Refer to paper '*Getting ready for the July 2024 Changes*', where I've highlighted in red, this requirement.) Cecil will send a copy of this paper to all members before the January Dinner meeting.

Implications

- Delays in sending Constitution for registration
- Ten days before a general meeting is required to notify members of a Resolution (Motion) to change the constitution
- This can be arranged for the February Dinner Meeting, but now the Constitution Committee has about 16 days in February to *complete* draft procedures, not just make a name change, and choosing to develop 'a compliant version'.
- OFT can take up to 6 weeks to approve registration.
- It may be possible that Registration by OFT could be approved in mid-April, a couple of weeks before AGM, but this is not certain.

Further, the Nominating Committee realizes there is an additional implication for 'terms of office' with delays past the April AGM.

GETTING READY FOR THE JULY 2024 CHANGES

Changes to how you resolve internal grievances and disclose remuneration to your members in your incorporated association will begin on 1 July 2024.

You should understand how they'll affect your organisation and what you need to do to get ready.

Dispute resolution procedures

Your incorporated associations will need to follow the grievance procedures in the model rules or adopt another compliant procedure into your constitution.

This will give associations a formal process to handle internal conflicts and help parties resolve them before they incur legal costs.

While the grievance procedure won't become part of the model rules until 1 July, you can <u>preview them</u> to see if you would like to use them or adopt your own.

If you don't have a grievance procedure

If you wish to follow the model rules' grievance procedure, you won't need to make any changes to your constitution—the model rules procedure will automatically apply.

If you wish to follow a custom grievance procedure, you will need to adopt it into your constitution.

If you already have a grievance procedure

If you already have a compliant grievance procedure in your constitution, you can continue to follow it. You will not need to make any changes to your constitution.

If your grievance procedure does not comply

If you have a grievance procedure in your rules that will not comply with the upcoming changes, it will be invalid and you will need to follow the model rules grievance procedure.

If you wish to follow your own grievance procedure, you will need to adopt a compliant version into your constitution.

How to create a compliant grievance procedure

When creating your own grievance procedure, it must comply with <u>section 47A of the Associations Incorporation</u> <u>Act 1981</u>, which means it needs to:

- allow a member to appoint any person to act on their behalf
- give each party an opportunity to be heard
- allow unbiased mediation if the dispute cannot initially be resolved
- ensure a decision-maker is unbiased if the grievance procedure allows a person to decide the outcome of the dispute.

If a grievance is not resolved

Sometimes grievances cannot be resolved within an association. This may be because the parties can't reach an agreement, or it may be that one or both parties would not follow the grievance procedure.

In this case, either party may apply to the Supreme Court to make a decision on the dispute.

The Office of Fair Trading (OFT) **cannot** settle disputes between associations and their members—only the Supreme Court can interfere with the running of an incorporated association.

Remuneration disclosure

From 1 July 2024, **all incorporated associations** will need to disclose remuneration and other benefits at their annual general meeting (AGM), even if the amount to report is zero. This applies to benefits and remuneration given to management committee members, senior staff and their relatives.

Remuneration and benefits may be disclosed as the total value given to all persons, but must include the number of people who benefited. This requirement will provide greater transparency and accountability within associations and enable members to assess if remuneration and benefits paid to key individuals were an appropriate use of the association's resources.

Incorporated associations registered with the Australian Charities and Not-for-profits Commission who are exempt from submitting annual financial reports to OFT **are not exempt from this requirement**.

How to disclose remuneration and benefits

Your association must disclose remuneration and other benefits at its AGM in either:

- a document required by the Act to be presented at your AGM (e.g. your financial statements or the information you provide to the ACNC)
- a written remuneration statement for the financial year.

If your association did not provide remuneration or other benefits, you can state this verbally, but it must be recorded in the AGM minutes.
